This agreement is designed to help guide the process and conversation as we finalize the details of your scholarship.

## WEF SCHOLARSHIP CHECKLIST

- Thoughtfully consider the purpose of this scholarship. Are you seeking to honor someone special?
   Establish a memorial? Promote a specific field or industry? Support a specific population, club, sport, or characteristic?

WEF administered scholarships utilize a common application process online. Donors/scholars representatives establish eligibility criteria that will be included through that application for each scholarship.
- Review the WEF selection process <a href="www.wws.k12.in.us/WWSEducationFoundation">www.wws.k12.in.us/WWSEducationFoundation</a>. Typically, donors do not participate in the selection process due to potential and/or perceived conflict of interest as well as tax implications.
- All scholarships require an initial contribution of \$5,000 with an annual scholarship amount of at least
   \$500
- Donors have choices in establishing scholarships and other restricted funds:
  - WEF partners with the Central Indiana Community Foundation (CICF) to support endowed funds. These funds are the most permanent and lasting commitment to our mission. HCCF named on behalf of WEF are restricted for Foundation use and are, therefore, protected by donor choice. HCCF manages the principal and allocates an annual spendable amount, typically 5%, for scholarship awards. Endowed funds are required to meet a minimum threshold.
  - Donors may also choose to invest in funds directly with WEF. WEF will draw on these funds to award scholarships. WEF maintains a restricted account separate from our operations account to ensure designated funds do not commingle with general funds.
  - ☐ In some situations, WEF may choose to accept "pass-through" donations. If this is an area of interest for you, please notify a WEF representative.
- Donors typically receive substantial tax benefits for establishing scholarship funds. Donors are encouraged to confer with tax advisors.

Established funds are irrevocable.
- 6. On the rare occasion, circumstances arise that make it illegal or impossible to use the funds as specified, an appropriate recipient cannot be identified, and/or a scholarship check is returned. In this event, WEF will attempt to communicate the issue to the Donor/Scholarship Representative and may submit a request for modification of the purpose. In the event WEF cannot reach the Donor/Scholarship Representative, the modification request will be submitted to the WEF Boards of Directors. In general, please indicate your preference:
